STRASBURG C-3 SCHOOL DISTRICT

PROPOSITION 2

Shall the Board of Education of the Strasburg C-3 School District of Cass County, Missouri borrow money in the amount of Five Hundred Thousand Dollars (\$500,000), resulting in no estimated increase to the debt service property tax levy, for the purpose of providing funds to complete heating, ventilation and air conditioning improvements, roof repairs and replacement, carpeting replacement, parking lot improvements, and complete other remodeling and repair improvements to the existing facilities of the District; and issue bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.12 per one hundred dollars of assessed valuation of real and personal property.

PROPOSITION A

Shall the Board of Education of Belton School District #124 of Cass County, Missouri, be authorized to issue its general obligation bonds in the amount of \$9,500,000 to acquire, construct, renovate, furnish, equip and improve its school facilities including without limitation the (a) addition of classrooms at the current Freshman Center campus to permit the relocation of grades 10 through 12 to this site, and the relocation of grades 7 through 9 to the current high school campus, (b) renovation of spaces at the Yeokum school site to permit the inclusion of vocational and other programs, and (c) renovation and improvements of its other school district facilities? If this proposition is approved, the adjusted debt service levy of the District is expected to increase from the current amount of \$1.18 to \$1.30 (an estimated increase of \$0.12) per one hundred dollars assessed valuation of real and personal property.
