**Sales Tax Total 5.850%**

To figure the specific sales tax rate of a city, take the rate shown for that city and subtract 5.850%. For example, the City of Raymore has an overall rate of 8.850%. By taking the 8.850% and subtracting 5.850%, the result is 3.000%. So 3.000% is the City of Raymore's portion of the sale tax rate. To put it in practical terms, if you buy something for a dollar at a store in Raymore, the State of Missouri receives 4.225 cents, Cass County receives 1.5 cents, the Emergency Services Board (911) receives 0.125 cents, and Raymore receives 3 cents.

It should also be noted that within several Cass County cities there are "special taxing districts", where there may be an additional sales tax to help pay for the development and infrastructure of that particular area. These special taxing districts are usually called Transportation Development Districts (TDDs) or Community Improvement Districts (CIDs). Most of these special taxing districts are located in the larger cities of Belton, Raymore, and Harrisonville.
